

**“Progressive Pit Crew” Sweepstakes
OFFICIAL RULES (“Official Rules”)**

NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, OR ADMINISTERED BY JOE GIBBS RACING, DENNY HAMLIN, OR INSTAGRAM.

By entering, you understand that you are agreeing to these Official Rules for the “Progressive Pit Crew” Sweepstakes (“**Sweepstakes**”) and to provide your information to Progressive Casualty Insurance Company (the “**Sponsor**” or “**Progressive**”) and for other purposes as specified in the Sponsor’s privacy policy, as further described in Section 10 below.

1. Entry Period:

The Sweepstakes entry period begins at 12:00:01 a.m. Eastern Time (“**ET**”) August 5, 2026 and ends at 11:59:59 p.m. ET August 12, 2026, (“**Sweepstakes Entry Period**”). The Sponsor will randomly select one (1) prize winner (“**Winner**”) from eligible entries to receive one (1) prize (“**Prize**”). All Entries must be received by Sponsor during the Sweepstakes Period; no late Entries will be accepted.

2. Eligibility:

The Sweepstakes is open only to legal residents of the fifty (50) United States (including the District of Columbia) who are at least eighteen (18) years old or the age of majority in their state of residence (which is nineteen [19] for residents of Alabama and Nebraska) at the time of entry (each an “**Entrant**”).

Employees of Sponsor and its affiliates, subsidiaries, agents, licensees and advertising and promotion agencies (collectively the “**Sweepstakes Entities**”) and the immediate families (spouse, parents, children and siblings and their respective spouses, regardless of where they reside) and individuals living in the same households of any of the foregoing individuals, whether or not related, are not eligible to participate.

All federal, state, and local laws and regulations apply. Void where prohibited or restricted by law. All Entrants agree to be bound by these Official Rules and the decisions of the Sponsor shall be final and legally binding in all respects. Winning a Prize is contingent on fulfilling all requirements in these Official Rules. Entrants and/or potential winners may be required to provide proof of identification, contact information (including an e-mail address and physical address; No PO Box please), and eligibility as required by Sponsor.

- Follow Sponsor’s official Instagram account at @progressive;
- Like the Sweepstakes post/video; and
- Comment on the Sweepstakes post/video with the hashtag #progressivepitcrew.

LIMIT: One Entry per person regardless of method during the Sweepstakes Entry Period.

Entry Notes: No Entry may be obscene, pornographic, violent, cruel, mean spirited, false or misleading, offensive in any manner, have swear words, or in any other way not suitable to be published, be derogatory of the Sponsor or the Released Parties. If an Entry falls into this category, it may be rejected by and become void in the sole discretion of the Sponsor.

WINNERS WILL BE DETERMINED BY A RANDOM DRAWING AS SET FORTH IN THESE OFFICIAL RULES FROM ALL ELIGIBLE ENTRIES SUBMITTED.

While it is free to enter, if you are accessing the Sweepstakes via a wireless mobile device (only available via participating wireless carriers), data rates may apply for each message sent or received, or for data usage while accessing the Sweepstakes through a mobile device, according to the terms and conditions of your service agreement with your wireless carrier. Submission of an Entry grants the Released Parties the worldwide, fully transferable and sublicensable right to publish, use, adapt, edit, publicly perform, and/or modify such Entry in any way, in any and all media or formats, and for any commercial or other purpose, including for use in advertising and marketing, without limitation, and without notice, review or approval and without additional compensation to Entrant except where prohibited by law. Each Entrant will defend, hold harmless and indemnify from any claims, liabilities, losses, lawsuits, penalties, and expenses (including attorney's fees) arising out of or related to any Entry and any violation of these Official Rules.

4. Random Drawing:

WINNER SELECTIONS: There will be one random drawing conducted by the Sponsor on or about August 17, **2026** to select one (1) winner from the eligible entries received. Odds of winning depend on the number of eligible entries received during the Entry Period. If the selected Winner is unable to accept a Prize in its entirety for any reason, the selected Winner will forfeit the Prize, and the Prize will be awarded to an alternate winner from all remaining eligible entries.

By accepting a Prize, the Winner irrevocably grant(s) Sponsor the right and permission (except where prohibited by law) to use their name, Prize won, likeness, photograph, voice, address (state) and biographical information in any media throughout the world in perpetuity for purposes of advertising, online posting, promotion and publicity in connection with the Sweepstakes without additional compensation.

5. Winner Notification:

Potential Winners will be notified via e-mail or direct message and have 24 hours from notification to respond to Sponsor. The failure to respond to such notification or a potential winner's noncompliance with these Official Rules may result in disqualification, and at the Sponsor's sole discretion, an alternate winner may be selected.

In the event of a dispute as to the identity of any Winner, the winning Entry will be declared made by the authorized account holder of the e-mail address used to submit such Entry and the authorized account holder must comply with these Official Rules. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider or other organization (e.g., business or educational institution) that is responsible for assigning e-mail addresses for the domain associated with the e-mail address used to enter the Sweepstakes.

6. Prize: One (1) Prize. The winner will receive a pair of Progressive-branded pajama slippers. Approximate Retail Value (ARV) of the Prize is \$38.68.

7. Governing Law/Disputes:

THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF OHIO WITHOUT REGARD TO CONFLICT OF LAWS PRINCIPLES. THE FORUM AND VENUE FOR ALL DISPUTES, CLAIMS, AND CAUSES OF ACTION ARISING OUT OF OR RELATING TO THE SWEEPSTAKES OR ANY PRIZE SHALL BE IN CLEVELAND, OHIO.

8. Release; Conditions of Participation:

By participating in the Sweepstakes, each Entrant agrees to: (a) comply with these Official Rules and the decisions of Sponsor, which are final and binding in all matters relating to the Sweepstakes; (b) permit Sponsor and its designees to use Entrant's name, likeness, biographical information, and other submitted content for advertising, promotional, and other lawful purposes in any media now known or later developed, worldwide and in perpetuity, without further notice,

permission, or compensation except where prohibited by law; and (c) waive any claim of ambiguity regarding these Official Rules.

No failure by Sponsor to enforce any provision of these Official Rules shall constitute a waiver of that provision. In the event of any conflict between these Official Rules and any advertising, promotional, or entry materials, these Official Rules shall control.
